In addition to the statutory conditions that apply to all licences granted under Section 38 of the *Therapeutic Goods Act 1989*, the following specific conditions have been imposed on the licence under Sections 40(1) and/or 40(2) of the *Therapeutic Goods Act 1989*:

The authorisation for chemical testing is restricted to the testing of Ethylene oxide residues by gas-liquid chromatography.

The authorisation for physical testing is restricted to the testing of sub-visible particles.

The licence also authorises the potency testing of antibiotics using bioassay, and disinfectant testing.
